# Job Description

Sport Ireland established the Local Sports Partnership (LSP) Network as an initiative to create a national structure to co-ordinate and promote the development of sport and physical activity at local level. LSPs aim to increase participation in sport and physical activity by breaking down barriers and increasing opportunities for physical activity and ensuring continued participation through all stages of life.

Donegal Local Sports Partnership are seeking to recruit a Community Active Play Officer to coordinate and deliver on the objectives of Active Play Donegal.

Active Play' involves a shift back to more recreational types of physical activities. 'Active Play' is a morefree form of play, which moves away from a very structured form of coaching to a form of play that enables children and adults of all ages to freely participate in different activities. Examples of active play include throwing ball, races, catching games, obstacle courses, hopscotch, rounders, recreational basketball, football, cricket, rounders, and many traditional games.

The successful candidate will be motivated by and committed to sports development and to increasing opportunities for participation, in particular among hard to reach groups in local communities. They will have an understanding of the public sector and community development environment.

#### **Role Responsibilities:**

- To deliver on the objectives of the existing Active Play Donegal programme in collaboration with the key stakeholders to promote the Active Play Donegal Model
- To provide opportunities for the key stakeholders including family resource centres, childcare facilities, primary schools, community organisations and the local statutory agencies involved in free play to come together to develop local action plans
- To promote a positive lifestyle choice for families involving a shift back to the more informal or free form of play which enables children and adults to participate in a range of fun recreational activities.
- To bring public spaces 'to life' through organised free play events which aim to attract children and their families.
- To provide training and education to support the development of Active Play Leaders and and support them to develop the confidence and skills to lead out on community play programmes.

- To develop play initiatives which support inclusion, diversity and community cohesion and a form of community engagement.
- Develop strong working relationships with relevant communities, support partners and Active Play Leaders
- Provide written and oral reports to the line manager, relevant steering groups, and Board, on progress and issues of relevance for the project.
- Carry out administrative duties as required

- **Communication Skills** Ability to consult, communicate and network appropriately and effectively with all sectors of the community. Excellent presentation and facilitation skills.
- **Funding and Budgeting** Ability to prepare, monitor and manage budgets and to prepare funding applications.
- Time Management Ability to manage time effectively with competing priorities
- IT/Administration Strong IT, administrative and organisational skills.
- **Relationship Building** A constructive, positive and progressive attitude to working as part of the team and an ability to develop partnerships with the wider community.

- Experience working as part of a project team
- Working knowledge of research methodology
- Coaching qualification/experience in leading community sport
